TERMS AND CONDITIONS

This agreement contains the terms and conditions by which Holidaze (a division of Five Star, Inc.) 810 Belmar Plaza, Belmar, NJ, 07719 ("Operator") in considerations for a Participant's payment, agrees to provide these travel tours.

READ AGREEMENT CAREFULLY BEFORE SENDING ANY MONEY. This tour is operated by Holidaze Ski Tours®.

PAYMENT SCHEDULE: \$150.00 DEPOSIT due now with application (see below); \$300.00 due Aug. 1st; \$550.00 due Oct. 1st; \$550.00 due Dec. 1st.; Balance due Dec. 15th.

PAYMENT: If payment is made by credit card: (1) a signed, fully completed credit card voucher for such payment, with proper authorization, must be received to secure reservations and (2) Participant(s) waive any charge back rights for services provided but not utilized. In the event of a dispute, requests for refunds must be made under the procedure described below.

CREDIT CARD PAYMENTS: Payment for this tour program may be made by Discover, Master/Card, or Visa to Holidaze. A surcharge of 3.0% for credit card payments will apply. If paying by credit card, please request voucher from Stephen Kirkland.

CANCELLATION CONDITIONS: Certain commitments for these arrangements have been, or are being made on your behalf in connection with the tour described on the reverse. Naturally, along with these commitments comes a certain responsibility on your part that will necessitate certain cancellation penalties in the event you cancel your tour arrangements prior to the departure date. All notices of cancellation must be received in writing at our office in order to be considered valid. The amount of refund, if any, will be determined by the following schedule in accordance with the date such notice is received: Cancel in writing up to 90 days prior No Penalty; Between 90 days and 60 days = \$100 pp*; Between 59 days and 30 days = \$150 pp*; Between 29 days and 15 days = \$250 pp*; after 14 days = 100% Penalty. (*Plus any further charges assessed by hotels, suppliers and airlines). \$25 fee for substitutions after Nov 15. No shows are non-refundable. Charges indicated are per person.

PRICING: Price subject to change based upon exchange rates, final number of participants, charges imposed by the airline and/or other situations out of control of tour operator. Air transportation prices are subject to changes due to regulations beyond our control. Triple/single pricing available upon request however, the participants need to find their own roommates for triple pricing.

BAGGAGE: You are normally allowed 2 pieces of checked baggage plus one carry-on piece that must fit under your seat. Porterage of the carry-on piece is your responsibility. Skis, boots & poles will count as one of your pieces of checked baggage. Baggage is at "owner's risk unless insured. Insurance is recommended and offered below.
